

## **Terms and Conditions**

## For First Nations Housing Community Housing Survey 2024 & Contest

**INTRODUCTION**: By participating in the First Nations Housing Community Housing Survey Contest 2024, you agree to comply with and be bound by the following terms and conditions. Please read these terms carefully before participating in the survey and contest. If you do not agree to these terms, please do not participate in the survey. You will be given the option to not participate in the survey.

**DATE OF CONTEST**: The survey and contest period will commence on Monday November 4, 2024, at 12:00:01am Eastern Standard Time ("EST"), and end on Monday November 25, 2024, at 11:59:59pm EST (the **"Contest Period").** Entries received after this period will not be eligible for the prize giveaway.

**ELIGIBILITY**: The Contest is open only to legal residents of Canada who are eighteen (18) years of age or older (or the applicable age of majority, if greater than eighteen (18) years of age in their respective jurisdictions) and that can enter into legally binding contracts under applicable law. As a prize winner, you will allow the use of your name and possible photo to be used for promotional purposes with the First Nation Housing Community. The following individuals are not eligible to enter the Contest and/or win a Prize: (a) employees, officers, and directors of the First Nations Housing Community, including its, subsidiaries, affiliates, partners, advertisers, marketing and promotion agencies, manufacturers or distributors of promotion materials, and representatives; and (b) members of the immediate family (parents, children, siblings, or spouses) of a person listed in (a) and/or those living in the same household as a person listed in (a), regardless of familial relation. All federal, state, provincial and local laws and regulations apply. Entrants agree to be bound by the terms of these Official Rules and by the decisions of the First Nations Housing Community, which are final and binding on all matters pertaining to this Contest. **How to Enter**: To enter the Contest, the Entrant must complete the First Nations Housing Community Housing Survey 2024. The Entrant must complete the survey in its entirety by submitting all answers to the survey questions, providing a valid First name, Last name, phone number and email address, and clicking **"Submit Survey"** to receive one (1) entry into the Contest. The survey must be completed by 11:59:59pm EST on Monday November 25, 2024

**Survey and Contest Period**: The survey and Contest period will commence on Monday November 4, 2024, at 12:00:01am Eastern Standard Time ("EST"), and end on Monday November 25, 2024, at 11:59:59pm EST (the **"Contest Period"**). Entries received after this period will not be eligible for the giveaway, unless extended by the contest organizers.



**Selection of Winners**: One (1) random draw from each participating Canadian Province or Territory (which includes: Alberta, British Columbia, Manitoba, New Brunswick, Newfoundland and Labrador, Northwest Territories, Nova Scotia, Nunavut, Ontario, Prince Edward Island, Quebec, Saskatchewan, Yukon) will be conducted, wherein the winner will be selected at random from all eligible Provincial entries received during the survey period. The draw will take place within 7 business days of the termination of the Contest Period. The odds of winning depend on the number of eligible entries received.

**Prizes**: One (1) prize will be awarded, consisting of a \$500 CAD Visa Gift Card, for each Canadian Province and Territory. The gift card is non-transferable and cannot be exchanged for cash. The prize must be accepted as awarded, and no substitutions will be provided.

If a winner does not respond to the notification within 7 business days or is found to be ineligible, the prize may be forfeited, and an alternate winner may be selected at random. Your personal information will not be shared with third parties, except as necessary to administer the prize giveaway.

In the event of termination, the First Nations Housing Community may or may not, at its discretion, conduct a random draw from all eligible entries received up to the time of termination.
